4.1	PASCO reauthorization	Committee mandate extended through 2035 ; members thanked Rep. Dent and Sen. Warnick for legislative sponsorship.
4.2	Tri-agency review	DOH found that only 3 of 60 worker-exposure insurance claims in 2024 reached compliance investigation. Agencies will hold quarterly case-reviews and improve data-sharing.
4.3	Investigation approach	Consensus to adopt a preventive, consultation-oriented style that addresses root causes rather than focusing solely on penalties.
4.4	Referral template overhaul	New narrative-rich referral form now auto-copies L&I-DOSH and WSDA; it is in effect immediately.
4.5	Training & outreach	DOH investigators will complete a custom

		equipment-identification course in July. Grower/manager-focused safety modules will be co-designed with ALP alumni and commodity groups. DOH will increase its presence at farm-worker safety events. A survey of growers' training needs will launch before November commodity conferences.	
4.6	Advisory Work Group vacancies	Only a fraction of the 11 seats are filled; targeted recruitment will occur via industry conferences and farm-worker radio.	
4.7	Agricultural Leadership P rogram	Current funding sunsets after two more cohorts. PASCO will explore a mixed public-private model and potential Climate Commitment Act dollars.	
4.8	Meeting schedule	Additional meeting planned for late Aug/early Sep 2025 and a regular session in Nov/Dec 2025 to align with legislative planning and recruitment cycles.
