Package Description

This proposal requests the following technical corrections to the Department of Health's 2017-19 appropriations.

SB 5689 DIABETES--PLANNING--REPORTS

DOH requests ongoing appropriation for Chapter 56, Laws of 2016 (SB 5689) consistent with the approved fiscal note. The fiscal impact of the legislation did not start for the Department of Health until the following biennium, therefore the appropriation was not included in the Department's carry-forward level or 2017-19 base budget. **Note:** The department had been directed and funded via budget proviso to perform this work in the 2015-17 biennial budget (Chapter 4, Laws of 2015, Sec. 219(3) (ESSB 6052)). SB 5689 continued the Diabetes reporting requirement but did not provide the continued funding.

This technical adjustment requests the following:

- Increase FY18 Appropriation: \$41,000 001-1 GF-State; FTE 0.3
- Increase FY19 Appropriation: \$41,000 001-1 GF-State; FTE 0.3

GLOBAL HEALTH STRATEGIES RURAL COMMUNITIES

Chapter 1, Laws of 2017 Section 219(25) provides that \$250,000 General Fund-State for fiscal year 2018 and \$250,000 General Fund-State for fiscal year 2019 are appropriated solely for the department to contract with a nongovernmental entity for a pilot program to develop strategies to address health disparities in rural communities. However, an additional \$250,000 General Fund-State for fiscal year 2018 and \$250,000 General Fund-State for fiscal year 2019 were not provided in the 2017-19 enacted budget. If these funds are not provided in the 2018 supplemental budget, the department will be forced to implement programmatic reductions from its base activities.

This technical adjustment requests the following:

- Increase FY18 Appropriation: \$250,000 001-1 GF-State
- Increase FY19 Appropriation: \$250,000 001-1 GF-State

2SSB 5052 (MEDICAL MARIJUANA--REGULATION)

Chapter 70, Laws of 2015 (2SSB 5052) states that the legislature intends that the cost associated with implementing and administering the medical marijuana authorization database shall be financed from the health professions account and that these funds shall be restored to the health professions account through future appropriations using funds derived from the dedicated marijuana account.

The department used \$3.0 million 02G to fund development of the medical marijuana database based on legislative directive. To date, a total of \$700,000 has been restored for the 2017-19 biennium. The department request additional restoration of the remaining \$2.3 million balance.

This technical adjustment requests the following:

- Transfer \$2,300,000 from the Dedicated Marijuana Account (Fund 315-1) the Health Professions Account (fund 02G-1) to reimburse the Department's actual FY16 expenditures to implement and administer the medical marijuana authorization database.
