Daim Npav Txhaj Tshuaj Tiv Thaiiv Kab Mob Yog Dab Tsi?

Daim Vax Card (Npav Txhaj Tshuaj Tiv Thaiiv Kab Mob) yog daim npav kaw tseg koj li kev txhaj tshuaj tiv thaiiv kab mob COVID-19 uas raug raws cai. Nyob rau lub sij hawm txhaj tshuaj tiv thaiiv kab mob, koj tsim nyog yuav tsum tau txais ib daim npav los ntawm Centers for Disease Control and Prevention (CDC, Cov Chaw Tswj thiab Pov Thaiiv Kab Mob) uas muaj hnub tim koj txhaj tshuaj tiv thaiiv kab mob thiab hom tshuaj tiv thaiiv kab mob COVID-19. Yog tias koj tsis tau txais ib daim npav los sis nws tau poob lawm, muaj lwm cov hauv kev los ua pov thawj rau koj tias koj tau txhaj tshuaj tiv thaiiv kab mob lawm (saib cov lus nug thiab cov lus teb hauv qab).

Dab tsi yog cov suav ua ntaub ntaww kaw tseg raug raws cai ntawm kev txhaj tshuaj tiv thaiiv kab mob?

Cov ntaub ntaww kaw tseg raug raws cai yog cov ntaub ntaww fab kev kho mob uas tau txheeb xyuas lawm uas tau txais thaum txhaj tshuaj tiv thaiiv kab mob, los ntawm koj tus kws muab kev pab cuam fab kev kho mob, los sis los ntawm lub MyIR cov vev xaib muab kev nkag mus rau kev pab cuam uas tau teev npe tseg saum toj.

Kuv tsim nyog yuav khaws kuv Daim Npav Txhaj Tshuaj Tiv Thaiiv Kab Mob cia li cas?

Koj tsim nyog khaws koj Daim Npav Txhaj Tshuaj Tiv Thaiiv Kab Mob cia rau qhov chaw kom muaj kev nyab xeeb! Xav tias daim npav no zoo tam li koj daim ntaww pov thawj yug los sis phau phav xab poj. Koj tuaj yeem muab nws thaij tau duab cia, muab theej tawm, muab daim theej tawm coj mus luam roj hmab tshooj (tab sis tsis yog daim thaum xub thawj), los sis siv lwm kauj ruam los ua kom ntseeg siab tias koj muaj cov theej tawm ntawm nws.

Koj tus me nyuam tsim nyog yuav tsum tau txais lawv tus kheej Daim Npav Txhaj Tshuaj Tiv Thaiiv Kab Mob ntawm CDC thaum uas txhaj tshuaj tiv thaiv kab mob. Nws yog ib lub tswv yim zoo uas koj khaws daim npav no cia yam uas muaj kev nyab xeeb rau lawv ib yam nkaus li koj khaws koj tus kheej li. Saib daim npe cov hauv kev xaiv txog kev khaws tseg saum toj.

Yog tias koj tus me nyuam tsis muaj Daim Npav Txhaj Tshuaj Tiv Thaiiv Kab Mob ntawm CDC, koj tuaj yeem tau txais ib daim theej tawm uas raug raws cai los ntawm lawv tus kws kho mob los sis tus kws muab tshuaj tiv thaiv kab mob.
