

# Apposun COVID-19 ren Serafo

Weweiti Mumuta ren Mwich kena seni Non Neniach ra kan Angangen Aninis ngeni Serafo.



Apposun COVID-19 kena iei ra kan kawor ngeni serafo ier 5 tori 17. Nge nupwen chomong sakkun amumuta ra kan pung fan annukun Washington state, chomong chon awora appos kena repwene kan mochen mumuta seni sam me in/chon tumun ren ar repwene ngeni emon serafo ekkewe appos. Ekkei taropwe ekkewe sakkun amumuta a kan mumuta fan annukun state, me pwan ifa usun eom we mwich epwene kan tongeni anisi ekkena serafo (akaewin ekkena serafo ese wor imwer) ar repwe angei appos ngeni ewe COVID-19.

## Aramas nap kena repwene tongeni amumuta ren serafo:



- Semom me inom
- Chon tumun ika chon tumun fan annuk
- Emon sam me in seni foster ika pwan ekkoch aramas kena ra kan mumuta seni ew amumuta seni kapung ngeni tumunun safei ren emon semirit non ew iseieno non imw nukun (Chapter 13.32A or 13.34 RCW)
- Emon aramas a kan angei ew sainin mumutan an epwe fori finitan tumunun safei rer
- Emon aramaser a kan tumunur ren ar tumunun safei
- Emon kangofen sukun, counselor, ika chon tipwenin ekkena ese wor imwer (ren emon serafo a awewen pwe ese wor imwen fan annukun mun nap McKinney-Vento Homeless Education Act)\*

## Serafo kena repwe kan tongeni amumuta ren pusin ir ika:



- **Ra kan nonom won pusin ir chok.** Ir ra kan ier 16 ika nap seni me pwan ra kan file me pwan ngenir nonomono won pusin ii seni semer me iner kewe.
- **Ir ra kan pupunu ngeni emon atemwan a kan nonomono won pusin ii ika emon aramas nap.**
- **Emon chon awora a kan finata ika ir ra kan emon atekis mi merit** fan ewe Annukun Atekis mi Merit (Mature Minor Doctrine).\*\*

### \*Ren chomong poraus won amumuta seni eaeenMcKinney-Vento:

Me fan annukun state, kangofen sukun kena, counseloren sukun kena, me pwan chon tipweni chon sukun kena ese wor imwer ra kan mumuta ar repwene awora amumutan ren appos ren emon serafo ese wor imwan ika atemwan (usun a kan awewe me fan ewe [federal McKinney-Vento homeless education act – Kapasen Merika chok](#)) ii ese kan nom fan tumunun inisin seni semen me inen ika chon tumun.

### \*\*Chomong poraus won ewe Mature Minor Doctrine:

Ekkoch chon awora kena ra kan mut ngeni atekin kena pwe repwe ngenir ew amumuta mi pung me fan ewe “Mature Minor Doctrine” ika pwe ir mi tongeni weweiti ika sisinei ekkewe met epwene fis seni ewe foforon safei.

Non finitan ika ewe chon safei ii emon atekis mi mirit, ewe chon awora epwene cheki ierin ewe atekis, tipachemen, miritin, kaeon, sisinean, an pusin won an ren moni ika ese wor noun, unusen napenapen usun emon aramas nap me pwan an nomono seni nemenemen semen me inen kewe.

# Chon awora kena repwene asepa ewe amumuta non ekkoch sakkun fofor.

- Mangungun amumuta (me won fon ika non aramas)
- Maaken amumuta (echo taropwe)
- Ekkoch ra kan mochen me ruwow maaken me pwan kapasen.
- Non - aramas amumuta seni ewe aramas nap a kan awora amumuta ren ir.

## Ifa usun eom kopwe anisi serafo kena ar repwe angei ar appos

- **Eaea ewe finin filterin won Kuten Appos (Vaccine Locator)** (<https://vaccinelocator.doh.wa.gov/?language=chk>) ika kori ewe chon awora ren eom kopwe sinei me sakkun amumuta ewe chon awora epwene kan asepa. The Youth Friendly finitan filterin won Kutan Appos (Vaccine Locator) epwene kan anisuk me pwan ewe serafo epwe kuna ew neni a kan angei ewe sakkun amumuta ewe serafo a kan tongeni awora. Nengeni “Aninis serafo repwe kan amona ren ewe sakkun amumuta repwene kan mochen awora” me fan ren poraus won amonen ren ew appointment.
- **Nenen ren nenien appos kena ra kan asepa chon chok etinong ika koko ren eom kopwe fori ew appointment.** Chomong chon awora ra kan eis ren amumuta seni sam me in ika chon tumun ren eom kopwe fori ew appointment online.
- **Awora wawan sai ngeni me pwan seni appointment ren appos.** Ika pwe en kose kan tongeni awora wawa, chek ren noum we chon nemenemen safean nenieom ika an Department of Health (DOH, Ofesin Pekin Safei) we [Apposun COVID-19 : Nenien aworan wawa \(Transportation Resources\)](#) – kapasen Merika chok. - **Chungeni sukun kena arun amumuta.** Ika pwe ewe serafo ka kan angang fiti a kan tufich ngeni ekkewe atetenin ren McKinney-Vento (nengeni me mwan ren chomong poraus), en kopwene kan tongeni angang fiti ewe kangofen sukun, counselorin sukun, ika chon tipweni chon sukun kena ese wor imwer ren kaworen amumuta. Ekkoch chon awora kena ra kan mochen emon aramas nap epwene kan nom nupwen ewe appos a fis. Afata ika ateteni fengen me chon angangen sukun me mwan ewe fansoun ren ami awpwe finata io epwene kan tongeni fiti ewe chon sukun ngeni ar appointment.
- **Afisi pusin eom asai fetanen appos ika awenano serafo kena ngeni ew nenien safei a fen wor.**

- **Anisi ekkena serafo ar repwe moneta ren ekkena sakkun amumuta repwene kan mochen repwe awora:**
  - Ika pwe emon aramas nap repwe kan mochen repwe nom nupwen an ewe atekis we appointment, ateteni fengeni fitir.
  - Ika pwe ewe chon awora a kan asepa maaken amumuta, anisi ewe atekis angei ewe taropwe kapinawow me pwan sain.
  - Ika pwe ir emon atekis ra kan pusin nonomono ren ir ika emon atekis a kan pupunu ngeni emon atekis a kan pusin nonomono ren ika emon aramas nap, anisir ar repwe ioi fengeni ekkewe taropwe epwe fich.
  - Ika pwe ra kan angei amumuta seni eaeen McKinney-Vento, uwato ew kapiin ewe annukun Asineiin Amumuta (Informed Consent law): RCW (Asiwinin Code seni Washington) [7.70.065](#)- kapasen Merika chok me pwan highlighteni ewe pekin mi chok ngeni ekkewe sukun.   - Ika pwe ra kan kute ar repwe amumuta me non ewe Annukunnnn Atekis mi Miritt (Mature Minor Doctrine), anisir amona taropwe me pwan poraus kena epwe pwarano pwe ir mi kan pusin wor ar seni semer me iner kewe. Ei ewe kan pwan ew meinisin chon kawor ra mochen nge epwe kan chok aninis.
