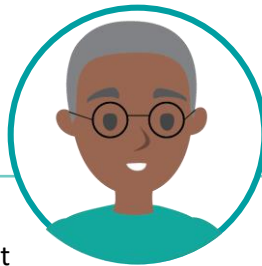


# COVID-19 Wa nan Jodikdik

Ilo am elon wawein melim ko rej bed iumin court ilo kien eo an Washington, elon ro rej lelak wa rej aikuj melim jen jinen ako jemen/rilale nan lelak wa nan jodikdik. Ej komman ilo pepa wawein melim kein rej lelak iumin kien eo an state, im elmen an doulol eo am maron in jiban jodikdik (elaptata jodikdik ro ejelok mwe mweir) bwe ren maron in wa jen COVID-19.

- Jinen ako jemen
- Rilale ako rilale eo ekar nan court
- Juon jinen ako jemen ako juon bar armij ewor an melim nan takto nan juon ajiri ilo juon jikin naboj-in-mweo (Chapta 13.2A ako 13.34 Revised Code of Washington (RCW, Code an Washington Emoj Kakaal))
- Lelak maron jen juon armij ikijen sign melim jen jinen im jemen nan kelet ikijen ejmour
- Lelak melim jen juon nukin ej bok eddo nan ejmour
- Juon nurse in jikuul, counselor, ako rijerbal ippen ro ejelok mweier (nan juon jodikdik emoj likit ainwot ejelok mwon iumin McKinney-Vento Homeless Education Act)\*

## Jodikdik remaron in lelak melim nan ir make ne:



- **Ekkar nan court remaron make lak iaer.** Rej 16 aer yio ako rittolak im emoj aer file im emoj lelak aer maron in make lak iaer jen jineir ako jemeir.
- **Emoj aer marry nan bar juon armij edik im ej bar make lak ian ako nan juon ritto.**
- **Juon jikin takto ej kwalok ke rej jot armij ro redik ako eritto kalmenlakjen** iumin Mature Minor Doctrine (Kien eo an Armij ro redik ako Eritto Kalmenlakjen).\*\*

Ilo kwalok ne rinaninmej eo ej juon armij eo edik ako eritto kalmenlakjen, jikin takto ko renij lale yio an ajiri eo, jonan jella, jonan ritto in kalmenlakjen, ta ko ekar ion e, an maron in make lak ian ako jako ijelakin, ta ko ej kommane ainwot juon ritto im make lak ian jen an jinen im jemen lale.

## Jikin takto ko rej bok jiban ilo jot wawein ko rej oktak.

- Lelak maron in kenan (ilo telephone ako ilo armij)
- Lelak maron in jeje (juon pepa)
- Jot rej aikuj melim ilo jimor jeje im kenan.
- Melim ilo-armij jen ritto rej lelak melim nan ir.

### Kilen jiban jodikdik boke wa eo aer

- **Kojobale kelet in lale Vaccine Locator (Kabbok Jikin Wa)** (<https://vaccinelocator.doh.wa.gov/?language=mh>) **ako call e jikin takto eo nan lale melim rot eo jikin takto eo ej boke.** Kilen kojobale kelet in lale nan Jodikdik ilo Vaccine Locator enij jiban eok im jodikdik eo kabbok jikin im ej boke melim eo jodikdik eo emaron in lelak. Lale "Jiban jodikdik kepojjak nan melim eo rej aikuj nan lelak" jiban ikijen kepojjak nan juon ien.
- **Kabbok jikin wa ko rej lelak etetal-lak ako call nan komman juon ien am etal.** Elon jikin takto ko rej kajitok ippen juon jinen ako jemen ako rilale melim nan kommane juon ien am etal.

- **Connect ippen jikuul ko kin melim.** Ne jodikdik ro kwoj jermal ippeir rej tobar jonan eo nan McKinney-Vento (lale maan nan melele ko relaplak), komaron in bar jermal ippen nurse in jikuul eo, counselor in jikuul, ako juon rilale rijikuul ro ejelok mweir nan lelak melim. Jot jikin takto ko rej aikuj an juon ritto bed nan wa. Kamol ako jermal ippen rijermal ro ilo mwon jikuul eo mokta jen ien nan kelet won enij maron in jiban rijikuul eo nan ien etal eo.
- **Komman am make burokram ebidodo etal nan e ako juon jikin kajju an jodikdik nan juon clinic emoj an bed mokta lak.**
