Apposun COVID-19 kena iei ra kan kawor ngeni serafo ier 5 tori 17. Chomong chon awora ra kan mochen emon sam me in ika chon tumun epwe kan amutata ren aramas kena ra kis seni ier 18 ren ar repwe angei appos. Nge ew chok, ika pwe en ka kan kis seni 18 me pwan pusin won eom seni semom me inom kena, en kopwene kan pusin amutata ren pusin en non ekkoch cases ika angei amumuta me seni eom sukun ika en ka kan osupwang ren aweiresin imweimwom me pwan kose kan nom ren semom me inom ika chon tumun. Ei taropwe epwne kan pwarano ekkewe sokopaten amumuta ra kan mumuta me fan annukun state, ifa usun eom kopwe kuta emon chon awora epwe anisuk, me pwan ifa usun amonan ren eom appointment ren appos.

Aramas nap kena ra kan tongeni amumuta reom:



- Semom me inom
- Chon tumun ika chon tumun fan annuk
- Emon sam me in seni foster ika pwan ekkoch aramas kena ra kan mumuta seni ew amumuta seni kapung ngeni tumunun safei ren emon semirit non ew iseieno non imw nukun (Chapter 13.32A ika 13.34 RCW (Asiwinin Code seni Washington))
- Emon aramas a kan angei ew sainin mumutan an epwe fori finitan tumunun safei rer
- Emon aramaser a kan tumunur ren ar tumunun safei
- Emon kangofen sukun, counselor, ika chon tipwenin ekkena ese wor imwer (ren emon serafo a awewen pwe ese wor imwen fan annukun mun nap McKinney-Vento Homeless Education Act)*

En ka kan pusin amumuta reom ika:



- **En ka kan nonom won pusin en chok.** En ka kan ier 16 ika nap seni me pwan ka kan file me pwan ngenuk nonomono won pusin en seni semom me inom kewe.
- **En ka kan pupunu ngeni emon atemwan a kan nonomono won pusin ii ika emon aramas nap.**
- **Emon chon awora a kan finata ika ir ra kan emon atekis mi merit** fan ewe Annukun Atekis mi Merit (Mature Minor Doctrine).**

*Ren chomong poraus won amumuta seni eaeen McKinney-Vento:

Me fan annukun state, kangofen sukun kena, counseloren sukun kena, me pwan chon tipweni chon sukun kena ese wor imwer ra kan mumuta ar repwene awora amumutan ren appos ren emon serafo ese wor imwan ika atemwan (usun a kan awewe me fan ewe [federal McKinney-Vento homeless education act](https://nche.ed.gov/wp-content/uploads/2018/10/youth.pdf) - Kapasen Merika chok) ii ese kan nom fan tumunun inisin seni semen me inen ika chon tumun.

**Chomong poraus won ewe Mature Minor Doctrine:

Ekkoch chon awora kena ra kan mut ngeni atekin kena pwe repwe ngenir ew amumuta mi pung me fan ewe "Mature Minor Doctrine" ika pwe ir mi tongeni weweiti ika sisinei ekkewe met epwene fis seni ewe fororun safei.

Non finitan ika ewe chon safei ii emon atekis mi mirit, ewe chon awora epwene cheki ierin ewe atekis, tipachemen, miritin, kaeon, sisinean, an pusin won an ren moni ika ese wor noun, unusen napenapen usun emon aramas nap me pwan an nomono seni nemenemen semen me inen kewe.

Chon awora kena repwene asepa ewe amumuta non ekkoch sakkun fofor.

- Mangungun amumuta (me won fon ika non aramas)
- Maaken amumuta (echo taropwe)
- Ekkoch ra kan mochen me ruwow maaken me pwan kapasen.
- Non - aramas amumuta seni ewe aramas nap a kan awora amumuta ren ir.

Poraus ren angaiin appos

- **Eaea ewe finin filterin won Kuten Appos (Vaccine Locator)** (<https://vaccinelocator.doh.wa.gov/?language=chk>) ika kori ewe chon awora ren eom kopwe sinei me sakkun amumuta ewe chon awora epwene kan asepa. The Youth Friendly finitan filterin won Kutan Appos (Vaccine Locator) epwene kan anisuk me pwan ewe serafo epwe kuna ew neni a kan angei ewe sakkun amumuta ewe serafo a kan tongeni awora. Ren awewe, ika pwe a kan wor emon aramas nap epwe kan tongeni amumuta reom nge ese kan tongeni epwe fituk ngeni eom we appointment, kuta emon chon awora kena epwe kan asepa maaken amumuta.
- **Nenen ren nenien appos kena ra kan asepa chon chok etinong ika koko ren eom kopwe fori ew appointment**, ika pwe en ese kan wor emon sam me in/chon tumun kena epwe kan tongeni amasowanong ewe taropwe online. Chomong chon awora ra kan eis ren amumuta seni sam me in ika chon tumun ren eom kopwe fori ew appointment online.
- **Chekenong ren eom we sukun.** Ika pwe en mi kan ani osupwangen weiresin non imwom, iwe McKinney-Vento meni epwene kan aeoeo ngonuk. (nengeni me mwan ren chomong poraus) En kopwene kan tongeni angang fengen me ewe kangofen sukun, counselor ika chon tipweni chon sukun ese wor imwer ren ar repwe awora amumuta.
- **Amon ren ewe sakkun amumuta en kopwene kan awora:**
 - Ika pwe emon aramas nap epwe kan nom nupwen eom we appointment, ateteni me ir.
 - Ika pwe ewe chon awora a kan asepa maaken amumuta, nengeni ika ewe aramas epwene kan awora amumuta epwe kan maakei me pwan sainsi ewe taropwe.
 - Ika pwe en emon atekis ka kan pusin nonomono seni semom me inom ika emon atekis a kan pupunu ngeni emon atekis a kan pusin nonomono seni semen me inen ika emon aramas nap, en kopwene kan mochen uwato ekkewe taropwe.
 - Ika en ka kan angei amumuta seni eaeon McKinney-Vento, me pwan noninen pwe ewe chon awora epwene kan wor a kapaseis kena, iwe en kopwene kan tongeni uwanong ew kapiin ren ewe annukun Asineiin Amumuta (informed Consent law): RCW [7.70.065](https://leg.wa.gov/RCW/default.aspx?cite=7.70.065) – [kapasen Merika chok](#) and highlight the portion specific to schools.  - Ika en ka kan kut amumuta ren pusin en me seni ewe Annukun Atekis mi Mirit (Mature Minor Doctrine), en meni kopwene kan mochen awora taropwen me pwan poraus kena ra pwarano pwe en ka kan nonomono seni semom me inom kewe. Ei ewe kan pwan ewe meinis chon kawor ra mochen nge epwe kan chok aninis. Ekkoch chon awora rese kan fori finitan miritn atekis non ewe neni nge ra kan chok asepa finitan miritin atekis seni ekkoch chon awora me mwan.
