Interviewer: Recently several people in Reedsport and the surrounding area got sick with an intestinal infection called Salmonellosis. We're interviewing people in the community to gather some information and figure out what's causing people to get sick and that can help protect others from becoming ill. I'm hoping to talk with a male between the ages of 20 and 49.

Interviewer: Is there someone in the household who fits that description?

Interviewee: Yeah I'm 33.

Interviewer: We've been interviewing the people who've been sick to find out what sorts of

food they ate and other activities they did that might put them at risk for infection.

Interviewer: We're also asking the same questions of people that didn't get sick. That way we can compare foods that sick people and well people ate and that helps us figure out what might have caused the illness.

Interviewee: That sounds great

Interviewer: Great, first I'd like to ask about the kinds of places where you might have eaten in the seven days before august 20th. This may help jog your memory about specific foods you might have eaten which I asked about a few minutes.

Monday, August 13th and Sunday, August 19. Did you eat anything at any fast food restaurants?

Interviewer: And don't you have a regular health care provider you could have used?

emergency room.

Interviewer: Alright. Next, I'm going to ask about where the food that Ryan ate during the seven days before he got sick came from. So this isn't necessarily where you shopped on those days but where the food he ate during that time came from.
