Dear Dialysis Center Coordinator:

On March 30, 2018 the Certificate of Need (CN) Program sent you a new CN¹ for PeaceHealth St. John's kidney dialysis facility. This new CN was making an administrative adjustment to your facility's approved stations to add one exempt isolation station consistent with WAC 246-310-809².

The program has identified an error in the number of approved stations stated in the CN's table. The enclosed replacement CN corrects this error.

You will need to apply to Centers for Medicare and Medicaid Services (CMS) for certification of each facility's additional station using the process required by CMS.

If you choose not to certify this exempt isolation station, you must notify the Certificate of Need Program of your intent to relinquish the exempt station and a revised Certificate of Need will be issued.
