Dear Dr. Nichols:

The Department of Health has completed its review of CMN Industries, PLLC Determination of Reviewability Ambulatory Surgery Center/Facility (ASF) request. Your application proposed a new ambulatory surgical facility (ASF) providing reconstructive and plastic surgical procedures in Thurston County, Washington. You represented in your determination of reviewability request that:

- CMN Industries, PLLC is a professional limited liability corporation.
- Christopher Nichols, MD is the sole owner and sole member of CMN Industries, PLLC.
- Upon opening, CMN Industries, PLLC clinical practice and surgical facility address will be: 145 Lilly Road, Suite 101 Olympia, WA 98506.
- CMN Industries, PLLC clinical practice and surgical facility address will be operated under the Unified Business Identifier [UBI] #604 240-221; and FEIN #82-4507803.
- Income derived from surgical services at CMN Industries, PLLC will be approximately 40% of total revenue generated by the ASF.
- Patient visits income that is for clinical services provided by the ASF will be approximately 60% of the total income generated at the ASF.
- Future owners or employees may have access to the ASF.
- CMN Industries, PLLC will have one operating room.
- CMN Industries, PLLC will not be operated as a separate legal entity from CMN Industries, PLLC practice.
- Clinical and surgical services provided at CMN Industries, PLLC will include those associated with reconstructive and plastic surgery procedures.

CONCLUSION

Based on the totality of information presented in the application and resulting research, the department concludes CMN Industries, PLLC does not require a Certificate of Need. Under this

determination, CMN Industries, PLLC, is authorized to provide reconstructive and plastic surgery procedures in one operating room.

If changes are made in the ownership, operation, services, or location, CMN Industries, PLLC may no longer qualify for this determination. In that event, Certificate of Need review and approval or new determination of reviewability request may be required.

APPEAL OPTION

This decision may be appealed. You or any person with standing may request an adjudicative proceeding to contest this decision within 28 calendar days from the date of this letter. The notice of appeal must be filed according to the provisions of Revised Code of Washington 34.05 and Washington Administrative Code 246-310-610. A request for an adjudicative proceeding must be received within the 28 days at one of the addresses listed on the following page.
