Annual Shellfish Growing Area Review

Activities in the Growing Area in 2022

Marine water stations 32 and 33, located in the Approved portion of the growing area, were sampled two times using the Adverse Pollution Condition (APC) criteria. This area is in Remote status. Stations 403, 404, 405, 406, and 427 were sampled six times. These stations are sampled using the Systematic Random Sampling (SRS) criteria. There is an approved relay from the Restricted portion of the growing area to the Shoal Bay Growing Area for scallop harvest. A routine three-year shoreline evaluation was completed and no new or changes in pollution sources were identified.

Analytical Results of Water Samples

Tables 1 and 2 summarize the results of the samples collected from the area. The water quality results from these stations are meeting the NSSP water quality standard. Station 427 only has 19 samples.

Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating that the area has any new sources of pollution.

Classification Status

- Well within the classification standards
- Meets standards, but some concerns
- Meets standards, but threatened with downgrade in classification
- Fails to meet current classification standards

Remarks and Recommendations

Table 1 and 2 shows that the stations meet the NSSP water quality standard for an Approved classification and the area is correctly classified.
