Annual Shellfish Growing Area Review

Activities in the Growing Area in 2022

The growing area was sampled 12 times in accordance with the National Shellfish Sanitation Program (NSSP) Systematic Random Sampling (SRS) criteria. Eleven samples were collected during the Open status. The Conditionally Approved portion of the growing area was closed nine times for a total of 52 days due to rainfall (≥1-inch in 24 hours). There is an approved relay from the Restricted portion to the Conditionally Approved portion for clams and oysters.

The Tacoma-Pierce County Health Department, Pierce County Surface Water Management, and Pierce Conservation District continued pollution identification and correction activities in the watershed. The Filucy Bay Shellfish Protection District continues to meet quarterly.

Analytical Results of Water Samples

Table 1 summarizes the most recent 30 samples collected from each of the sampling stations. Four of these samples were collected during Closed status. More data needs to be collected following rainfall greater than 1-inch to appropriately evaluate the classification of the area. After removing Closed status data, Station 764 is categorized as Concerned with an estimated 90th percentile of 20.5 FC/100mL.

Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating the area has any new sources of pollution.

Remarks and Recommendations

Tables 1 shows that all stations meet the required NSSP water quality standards and the area is correctly classified. The Department should continue to work with Tacoma-Pierce County Health Department, Pierce County Surface Water Management, Pierce Conservation District, and others to identify and correct sources of pollution in the watershed. Because limited rainfall-related sampling data was collected from 2020 through 2022, a special study that includes rainfall event sampling (exceeding 1-inch in 24 hours) should be completed prior to a classification change in the Conditionally Approved area.


