Activities in the Growing Area in 2023

The growing area was sampled a minimum of six times in accordance with National Shellfish Sanitation Program (NSSP) Systematic Random Sampling (SRS) criteria. Station 224, in the Conditionally Approved area, was sampled 12 times including 8 times in Open status. The Conditionally Approved portion is closed from September through December based on seasonal water quality conditions.

Analytical Results of Water Samples

Table 1 summarizes the most recent 30 samples collected from each of the sampling stations. It includes samples collected when the Conditionally Approved area was closed to harvest. All stations meet NSSP criteria. Table 2 shows that over 13 percent of the most recent 15 samples collected during the closed period exceed 43.0 FC/100mL at Station 224.

Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating the area has any new sources of pollution.


