Annual Shellfish Growing Area Review

Activities in the Growing Area in 2022

The growing area was sampled a minimum of six times in accordance with National Shellfish Sanitation Program (NSSP) Systematic Random Sampling criteria. Marine stations (1, 2, 11, 12, 871, 548, 575, 9, 549, 550, 869, and 870) near Allyn and within the Conditionally Approved and Prohibited areas were sampled 12 times. Stations 7, 548, and 575 in the Conditionally Approved area were sampled 10 times during Open status. The Conditionally Approved areas were closed nine times for a total of 53 days due to rainfall (≥1-inch in 24-hours). The entire growing area was closed once for seven days due to greater than three inches of rainfall in 24-hours.

Mason County received EPA National Estuary Program funds to implement pollution identification and correction activities identified in the North Bay pollution closure response plan.

Analytical Results of Water Samples

Table 1 summarizes the results of the last 30 samples collected from the area. This summary shows that all stations in Approved and Conditionally Approved areas pass the NSSP water quality standard; however, the Conditionally Approved areas only has five sampling events with rainfall exceeding 1-inch in 24 hours. Before a reclassification can be considered, more data following 1-inch of rain in 24 hours needs to be collected. Stations 1, 11, and 12 in the Approved area are categorized as Concerned. Stations 7, 548, and 575 in the Conditionally Approved area are categorized as Concerned during Open status.

Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating the area has any new sources of pollution.

Remarks and Recommendations

Table 1 shows that all stations meet the NSSP water quality standards for an Approved classification and the area is correctly classified. Because limited rainfall-related sampling data was collected from 2020 through 2022, special studies that include rainfall event sampling (exceeding 1-inch in 24 hours) should be completed prior to a classification change. The Department should continue to collaborate with Mason County to identify and correct sources of pollution in the North Bay watershed.


