Activities in the Growing Area in 2023

The growing area was sampled six times in accordance with National Shellfish Sanitation Program (NSSP) Systematic Random Sampling criteria. A routine shoreline survey was conducted, and no Direct or Indirect Impacts were identified.

All of the North River Shellfish Growing Area was closed from 12/5/2023 at 3:00 PM to 12/12/2023 at 4:30 PM, due to the Willapa River exceeding 21 feet.

Analytical Results of Water Samples

Table 1 summarizes the results of the last 30 samples collected from the area. This summary shows that all stations pass the NSSP water quality standard.

Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating that the area has new sources of pollution.


