

Number* of Children Served by Children with Special Health Care Needs Program by Age Group and Year




Number* of Children Served by Children with Special Health Care Needs Program by Gender




Number and Percent of Babies Born with Low Birth* Weight (less than 2,500 grams)



Age-Specific Hospitalization Rate* for Chronic Conditions per 1,000 Children Ages 0-19




