#### **Agency Recommendation Summary Text:**

The Department of Health is requesting funding to support the migration of 425 servers to the State Data Center (SDC) managed by Washington Technology Solutions (WaTech) beginning January 1, 2019. This request will bring the agency into compliance with RCW 43.105.375 and maximize the use of the SDC.

## **Package Description**

The Legislature directed state agencies, through RCW 43.105.375, to locate all existing and new servers within the State Data Center (SDC) located in Olympia. The Office of the Chief Information Officer (OCIO), in consultation with the Office of Financial Management (OFM), is responsible for implementing the business plan and migration schedule for moving all state agencies in the SDC. OCIO Policy 184 requires agencies to migrate datacenters or receive a waiver by June 2019. If funded, DOH would move 425 servers during the period of January 2019 through June 2020.

This request would bring the agency into compliance with RCW 43.105.375 and OCIO Policy 184 which are intended to maximize the use of the SDC.

Although the OCIO Technology Strategy Report states that DOH's Tumwater data center is a quality asset built to sound technology standards, its equipment and infrastructure will eventually need to be replaced. By shifting to the SDC, DOH will begin realizing cost avoidance benefits in approximately seven to ten years, when current data center equipment is projected to become obsolete. DOH does not anticipate any cost reductions for staffing or operational costs from this proposal, however.

- The Department of Health (DOH) assumes that this change will optimize the use of the SDC and help agencies avoid the cost and complexity of maintaining their own server rooms and data centers. The SDC provides the necessary space, power, cooling, connectivity, and security (physical and network) for the server, storage, and networking equipment of agencies that use it. The SDC is said to operate more efficiently and provide better physical and virtual security and resiliency than any other state agency space.
- DOH assumes that moving its servers to the SDC will result in overall decreased costs to the state as it is said to use power more efficiently than individual, smaller, and older facilities.

The Legislature directed state agencies, through RCW 43.105.375, to locate all existing and new servers within the State Data Center (SDC) located in Olympia. The Office of the Chief Information Officer (OCIO), in consultation with the Office of Financial Management (OFM), is responsible for implementing the business plan and migration schedule for moving all state agencies in the SDC.

#### What alternatives were explored by the agency and why was this option chosen?

DOH's Tumwater data center is considered a suitable data center and a quality asset that is built to sound technology standards. One alternative, from a strategic standpoint, is to migrate other agencies that do not have a viable facility first.

#### What are the consequences of not funding this request?

The Department would not be in compliance with state law and OCIO Policy.

#### How has or can the agency address the issue or need in its current appropriation level?

The Department of Health (DOH) does not have sufficient existing appropriation to address this issue. Without sufficient funding, DOH would need to secure a waiver from the Office of Chief Information Officer (OCIO) per RCW 43.105.375 to allow the continued use of the existing DOH data center.
