OPEN SESSION

1. CALL TO ORDER – The business meeting of the Athletic Training Advisory Committee (committee) was called to order at 10:01 a.m. by Cynthia Joy Wright, PhD, ATC, Chair.

1.1. Introductions

The committee and staff introduced themselves.

1.2. Approval of Agenda

1.3. A motion was made and seconded to approve the agenda as presented. The agenda was approved as presented.

1.4. Approval of Meeting Minutes

A motion was made to approve the December 17, 2018 meeting minutes. The committee voted in favor of approving the December 17, 2018 meeting minutes as presented.

2. OFFICE OF INVESTIGATION AND LEGAL SERVICES (OILS) OVERVIEW – Marc Defreyn, OILS Director, Marlee O'Neill, OILS Deputy Director, and Patrick Hanley, Staff Attorney presented information to the committee about the office of investigation and legal services.

Mr. Defreyn, Ms. O'Neill, and Mr. Hanley presented an overview of the disciplinary process including:

- Complaint intake
- Case Management
- Investigation
- Roles of the supervising staff attorney and staff attorneys
- Compliance

Mr. Defreyn shared that discipline is very low for the profession of athletic trainers.

3. LEGISLATION UPDATE – Mr. Brown and Mr. Bronoske presented information to the committee about legislation that may impact athletic trainers.

Mr. Brown updated the committee on recent legislation including:

- House Bill 1198 Requiring health care providers sanctioned for sexual misconduct to notify patients.
- House Bill 1753 Requiring a statement of inquiry for rules affecting fees related to health professions.

Mr. Bronoske provided an update to the committee on Senate Bill 5688 – Concerning athletic trainers. He shared that this bill included language stating only licensed athletic trainers are allowed to use the title "athletic trainer." The bill also eliminated the term "authorized volunteer" from RCW 18.250.050.

4. PROGRAM REPORT

4.1 Interim Operating Budget Report

Ms. Bronoske presented the athletic training budget and stated that there was nothing abnormal or concerning noted. Revenue continues to exceed expenditures.

4.2 Rules Update

Mr. Bronoske shared that he will begin the rules process for suicide prevention training.

4.3 Athletic Training Discipline Statistics

Mr. Bronoske shared that there had been two complaints and both were closed. One was for unlicensed practice and the other was for unprofessional conduct.
