Open Session

Call to Order and Introductions – Kirk Breuninger, Chair

Dr. Breuninger took roll call and outlined the topics to be discussed during today's meeting.

1. Approval of Agenda

Dr. Vang made a motion to approve the agenda for this meeting. Kim Morgan, LVT, seconded the motion. Motion carried.

Board Business

2. Open Forum (limited to 10 minutes)

Candace Joy, WSVMA, asked about the status of the client communication rule. Loralei Walker said the CR103 has been delayed due to the current health crisis.

3. Issues Related to COVID-19 Outbreak (Discussion/Action)

The board reviewed and discussed three documents – Veterinary-client-patient relationship (VCPR) policy statement, the continuing education (CE) policy statement and the essential services guidance statement.

VCPR policy statement

Brad Burnham explained the process for policy statements and our office director's preferred format for policy statements. Dr. Senestraro made a motion to approve the draft policy statement as written and move it forward for approval. Dr. Vang seconded the motion. Motion carried.

CE policy statement

After discussion, Dr. Senestraro made a motion to approve the draft policy statement as written and move it forward for approval. Dr. Vang seconded the motion. Motion carried.

Essential Services Guidance statement

The board discussed what comments/notes should be included in the client's record. The board agreed that each provider can decide what should be put in the record. Dr. Senestraro made a motion to accept language as written and move it forward for approval. Dr. Moriyasu seconded the motion. Motion carried.

After further discussion, Dr. Senestraro made a motion to amend the previous motion to now approve all language in the document except the paragraph mentioning medical records. Dr. Vang seconded the motion. Motion carried. DOH staff will work with Jeff Wise, policy analyst, to decide the best way to disseminate this guidance.

The board discussed changing the meeting times for the next two special meetings to begin at 8:00 a.m. and end at 9:30 a.m. Dr. Moriyasu made a motion to change the meeting time to begin at 8:00 a.m. Dr. Vang seconded the motion. Motion carried.
