Open Session

Call to Order and Introductions – Kirk Breuninger, VMD MPH DACVPM, Chair Kirk Breuninger, Chair, called the meeting to order and took roll call. Everyone who attended this meeting may not be included above.

1. **Approval of Agenda**

2. Open Forum (limited to 10 minutes)

The board accepted comments from the audience on issues of significance to the profession. During this time of emergency, the Board will consider only those matters which are routine and essential.

3. Issues Related to COVID-19 Outbreak (Discussion/Action)

The board discussed policy issues regarding COVID-19 and possibly adopt policies, conduct rulemaking, or otherwise act in response to the COVID-19 outbreak.

• Review of continuing work from past meetings

Brad Burnham gave an update on the veterinary-client-patient relationship and continuing education policy statements. They have been reviewed and approved and moving forward to Jeff Wise, policy analyst.

Graduating WSU students – May 9th is WSU graduation day. Brad Burnham has not been able to get in contact with WSU registrar's office via email or phone. Tanya Mills said credentialing office has applications from veterinary students and is waiting for transcripts from WSU. In the past, WSU sends transcripts to DOH in a timely fashion after graduation and she sees no reason why that won't happen this year. Brad will continue trying to contact WSU staff. Lisa Kelley, AAG, mentioned a possible solution would be for the student to write an attestation they have graduated much like licensees do for CE when they renew their licenses. Another option is for WSU registrar's office to send letter stating student has graduated.

• Supervision of veterinarian technicians and staff

The board discussed supervision of staff and remote supervision. The board took no action on this topic.

• Dispensation of prescriptions

Discussion of relaxing rules and veterinary medication clerk (VMC) certification requirement to dispense medicine. Discussion of doing personal inspections for prescriptions remotely. Brad Burnham, Jeff Wise, Lisa Kelley and Loralei Walker will meet to discuss options for medication dispensing. The board will hold on making decisions for more research to be done on subject.
