Parking

Free weekday 2-hour parking is available at The Olympia Center. Program Participants may pick up a parking permit at Customer Service for stays longer than 2 hours. Parking is free after 5:00 and on weekends.

- **Columbia & State Street lots** (see map above): 2 hours free OR all day with permit. Please refer to posted signage in the State Street lot for boundaries with leased parking.
- **Capitol Way - Senior Services Member lot**: pink Senior Services Member permit required, with the exception of disabled parking stalls. No disabled parking without permit in non-disabled stalls.
- **Disabled Stalls**: Vehicles with a properly displayed disabled placard or license plate may park for free in disabled stalls in all Olympia Center lots and at all metered parking spots.
- **Metered Parking**: All meters accept coins and Pay by Phone. Newer meters also accept credit/debit cards. The first 15-minutes are free at most meters.
