1. CALL TO ORDER

The business meeting of the Acupuncture and Eastern Medicine Advisory Committee (committee) was called to order at 9:00 a.m. on Friday, February 12, 2021 by Inderjeet Ramgotra, EAMP, Chair

1.2 Approval of Agenda

The committee reviewed and approved the February 12, 2021 meeting agenda as presented.

1.3 Approval of Meeting Minutes from November 20, 2020

A motion was made by Lisa vanHaagen and seconded by Lisa Miller to approve the November 20, 2020 meeting minutes as presented. The committee voted in favor of the motion and the November 20, 2020 meeting minutes were approved as presented.

2. 2021 LEGISLATION UPDATE

2.1 Department of Health Weekly Legislative Update conference call – Update - Lisa vanHaagen, EAMP and Lisa Miller, Public Member

Lisa vanHaagen and Lisa Miller provided information to the committee about the weekly Legislative Update conference calls. She shared that the calls included information on legislative bills affecting multiple professions and healthcare. Ms. vanhaagen mentioned SB 5124 – Colon hydrotherapy. This bill would create a certification under the Board of Naturopathy.

2.2 2021 Legislation Update – Trina Crawford, Executive Director

Ms. Crawford provided the committee an update on 2020 legislation. She shared information on the following bills:

- SB 5018 Acupuncture and Eastern medicine
- SB 5229 Health equity continuing education for health care professionals.
- ESHB 1056 Open Public Meetings Act and emergencies
- HB 1196 Audio-only telemedicine
- **3. OPEN PUBLIC MEETINGS ACT (OPMA)** Joyce Roper, Assistant Attorney General (AAG) will provide abbreviated training on the OPMA.

Ms. Roper provided reminders to the committee regarding the OPMA. She mentioned that if a violation of the OPMA has been determined, there is a \$500 fine that the state does not pay for. The committee was reminded that as they are a small committee, that three members are considered to be a quorum. If you are talking to other members, only two members should have any discussion outside of a meeting. Lastly, if you have an email from department staff, do not use reply all. Reply only to staff and they will link in the other committee members.

 - 4.1 Interim Operating Budget Report

Ms. Crawford provided committee members with an updated budget report through December 2020. The report continues to show revenue is exceeding expenditures. The department is continuing to have discussions regarding the lowering of fees.

Ms. Brown provided an updated licensing and disciplinary statistics report showing the number of licensees. The report listed the following:

She stated that as of today, there have been no comments posted regarding the rules on the Rules Comment website. She also stated that if substantive comments are received at the hearing, that the department will have to start the CR-102 process from the beginning and another hearing will be held.

Leslie Emerick stated that SB 5018 was the first bill heard and voted on the Senate Health and Long-Term Care Committee. She talked with Senator Rivers and the bill will be pulled to the floor to be voted on. The association had to rerun the bill in 2021 as there were some technical drafting issues with the bill in 2020 that they had requested the Governor to veto.

Ms. Emerick stated she is excited about the upcoming CR-102 rules hearing on Chapter 246-803 WAC.

Ms. Emerick ended with saying that by the next meeting, the list of bills will be significantly shorter.
