- **Chart of certification categories**
 - Information and Assistance
 - Behavioral Health Support
 - Intervention, Assessment and Treatment
 - Outpatient court-ordered/involuntary
 - Outpatient Crisis

Recap 8.4

- Information and assistance
 - Alcohol and drug information school
 - Move under outpatient court-order/referral and consider keeping non-court order version here
 - Emergency service patrol
 - BH telephone support
 - Supportive housing and supported employment
 - HCA recommends keeping
 - Majority prefers to move these services to BH support category

Recap 8.4

- **BH Support Services**
 - Peer support
 - Peer respite
 - Most likely turn into its own certification category
 - Applied behavioral analysis
 - Special workshop will be scheduled
 - Consumer-run clubhouse
 - Rehabilitative case management mental health services
 - Consider breaking out case management and care coordination
 - Psychiatric medication management services
 - Revisit in next draft
 - Medication monitoring services
 - Day support mental health services
 - Crisis stabilization
 - Rename to crisis support

Recap 8.4

- **Intervention, assessment, and treatment**
 - Individual mental health treatment services
 - Brief mental health intervention treatment services
 - Group mental health therapy services
 - Family therapy mental health services
 - Substance use disorder level one outpatient services
 - Substance use disorder level two intensive outpatient services
 - Substance use disorder assessment only services
 - Combine into:
 - Assessment
 - Counseling/therapy
 - Partial hospitalization program

Recap 8.4

- **Intervention, assessment, and treatment continued**
 - Outpatient less restrictive alternative or conditional release under chapters 71.05 or 71.34 RCW;
 - Substance use disorder counseling, driving under the influence (DUI) substance use assessment, or alcohol and drug information school under chapter 46.61 RCW; or
 - Deferred prosecution under RCW 10.05.150.

Recap 8.4

- **Outpatient Crisis Services**
 - Crisis outreach
 - Provided in the community
 - Crisis observation
 - Provided in an agency/facility, <24 hour model
 - Determine a title for the service
 - Potentially build some minimum standards around this model

Recap 8.4

- “Nested” certifications
 - Discussed the idea of agencies certified for higher levels of service/care being able to provide the lower levels of care without having to get separate certifications
 - Ex. If the agency is certified for intervention, assessment and treatment the agency could also provide support services as part of the intervention, assessment and treatment certification.
- **De-silo MH and SUD services as much as possible**
 - We’ll discuss more when next draft of rules is shared
 - Keep thinking. Ex. Should psychiatric medication management become BH medication management?
