We ensure communities have access to important state-wide data to ensure data driven solutions. OHSC strives to build capacity and sustainability to promote, develop, and implement prevention-based systems beyond the established program funding areas. Our areas of expertise include community-based prevention, injury and violence prevention, and cancer prevention and control.

MAJOR PRIORITIES

Enhance behavioral health systems to support people in crisis and prevent suicide (e.g., 988)

Support comprehensive cancer prevention and control

Conduct community-based programming to address commercial tobacco/vape and cannabis use

Support healthy, equitable, and culturally relevant food systems (e.g., fruit and vegetables incentives program)

Support community environments with increased access to active living

Prevent heart disease, stroke, and diabetes

Prevent unintentional injury, including motor vehicle accidents, traumatic brain injuries, and older adult falls

Prevent violence, including suicide, firearm- and gender-based violence

Promote oral health



BUDGET

For the 2023–25 biennium, the Office of Healthy and Safe Communities budget is \$121.9 million with interagency reimbursements (IARs) included. This includes Federal (22%), General Fund State (8%), and total dedicated funds (69%) for youth tobacco prevention, call centers, dedicated marijuana funds and other sources.


The office has 81 FTEs consisting of full time and project staff, plus IT support staff. Staff are located in Tumwater.
