## \*Application Fee Instructions:

CDL decontamination contractor certification expires annually on the expiration date of the applicant's L&I General Contractor Registration. Therefore, a CDL certification may be valid for less than one year. Calculate the fee at \$93.75 per month and count any partial month as an entire month for the purpose of calculating the fee. Application fee for an entire 12 months is \$1125 (For example: If your L&I Contractor Registration expires on September 12 and you apply for CDL Certification on April 23, the fee would be calculated at \$93.75 times six months = \$562.50.)
