Important Social Security Number Information:

If you have a Social Security Number, the law requires you to disclose it on your application for a professional or occupational license. [42 U.S.C. § 666\(a\)\(13\)](#); [RCW 26.23.150](#). It will be used under the state’s child support enforcement program to locate individuals for purposes of establishing paternity and establishing, modifying, and enforcing support obligations. You are not required to have or obtain a Social Security Number to apply for or obtain a license from the Department of Health. If you do not have a Social Security Number, you are still eligible to apply for and obtain a credential if you meet the requirements. Application Instructions Checklist

Important background check Information: Washington State law authorizes the Department of Health to obtain fingerprint-based background checks for licensing purposes. This check may be through the Washington State Patrol and the Federal Bureau of Investigation (FBI). This may be required if you have lived in another state or if you have a criminal record in Washington State. This would be at your own expense.

All information should be printed clearly in blue or black ink. It is your responsibility to submit the correct required forms.

Application Fee. This fee is non-refundable. You can check the online [fee page](#) for current fees.

1. Demographic Information:

Social Security Number: You must list your social security number on your application. You are not required to have or obtain a Social Security Number to apply for or obtain a license from the Department of Health. Please see the [Declaration of No Social Security Number Form](#). Please call the Chiropractic Quality Assurance Commission at 360-236-2822 if you do not have one.

National Provider Identifier Number (NPI): The National Provider Identifier (NPI) is a standard unique identifier for health care professionals available from the Federal Centers for Medicare and Medicaid Services. The NPI is a 10 digit numeric identifier. If you have a NPI number, provide this on your application.

Legal Name: List your full name: first, middle and last.

Definition of legal name: “Legal name” is the name appearing on your official certificate of birth or, if your name has changed since birth, on an official marriage certificate or an order by a court. The court must have the legal authority to change your name. We may ask you to prove your legal name. If you use any name other than your legal name on this form, your application may be denied.

Birth date: Provide the month, day and year of your birth.

Address: List the address we should use to send any information about your license. Be sure to include the city, state, zip code, county, and country. This will be your permanent address with Department of Health until we have been notified of a change. See [WAC 246-12-310](#).

Phone, Fax, and Cell Numbers: Enter your phone, fax, and cell numbers, if you have them.

Email: Enter your email address, if you have one.

Other Name(s): Indicate whether you are known or have been known under any other names. If you have a name change, you must notify the Department of Health in writing. You must include proof of this change. See [WAC 246-12-300](#).

2. Personal Data Questions:

All applicants must answer the same personal data questions. They are focused on your fitness to practice the essential skills of this profession.

If you answer “yes” to any questions in this section, you must provide an appropriate explanation. You must also provide the documentation listed in the note after the question. If you do not provide this, your application is incomplete and it will not be considered.

- Question 5 includes misdemeanors, gross misdemeanors and felonies. You do not have to answer yes if you have been cited for traffic infractions. You can get copies of court records through the county courthouse where the conviction, plea, deferred sentence, or suspended sentence was entered.
- Another jurisdiction means any other country, state, federal territory, or military authority.

3. Training and Education:

List in date order all colleges, universities, and chiropractic school(s). Include all periods of time from pre-chiropractic school to present, whether or not engaged in activities related to chiropractic. Attach additional completed pages if you need more space.

4. Experience:

List in date order all your professional experience and practice from date of graduation from chiropractic college. Attach additional pages if you need more space.

5. Other License, Certification, or Registration:

List all states where credentials are or were held. Attach additional pages if you need more space.

6. Practice/Teaching Attestation:

Required by [WAC 246-808-135](#)

7. Applicant’s Attestation:

You must sign and date this for us to process the application.

For Spouses and Registered Domestic Partners of Military Personnel Being Transferred or Stationed in Washington:

Under state law, if you are the spouse or state-registered domestic partner of a servicemember of any branch of the U.S. Military, to include Guard or Reserve, and are applying for a health care professional credential in this state, you may be eligible to have the processing of your application expedited to receive your credential more quickly.

Documents to submit with your application should include the following:

- A copy of your spouse’s or registered domestic partner’s military transfer orders to Washington State.
- One of the following:
 - A copy of your marriage certificate to show proof of marriage; or
 - A copy of a state’s declaration or registration showing you are in a state registered domestic partnership with a member of the U.S. military.

License Requirements

Thank you for applying for become a Chiropractor in Washington State. The Commission has determined that the licensing requirements of all states of the United States, the District of Columbia, Puerto Rico, Guam, and the U.S. Virgin Islands are “substantially equivalent” to those of chapter 18.25 RCW and 246-808 WAC. Applicants of other territories of the United States or Canada may still apply for a license to practice as a chiropractor via endorsement and the Commission will determine if their qualifications are “substantially equivalent” to those of chapter 18.25 RCW and 246-808 WAC on a case-by-case basis.

An applicant from a jurisdiction whose qualifications are deemed “substantially equivalent” to those of chapter 18.25 RCW and 246-808 WAC is not guaranteed to be issued a license to practice as a chiropractor, as the Commission has authority to deny an application if the applicant does not meet requirements for licensure, such as failure to successfully pass the Commission’s jurisprudence examination.

In order to qualify for licensure by endorsement you must complete the following:

Complete and submit the application and [fee](#).

Jurisprudence Examination:

After all documents have been received and the application is complete, the jurisprudence examination will be mailed. You will have 30 days from the date of receipt to complete and return the following:

- Examination Booklet
- Answer Sheet
- Comment Sheet

Your chiropractic license will be issued after successfully passing the jurisprudence examination with a minimum score of 95 percent.

Letter of recommendation:

You must have one letter of recommendation. This is a form attached within the application packet.

Other License, Certification, or Registration:

Print the verification form and provide it to each state or jurisdiction in which you held a credential, requesting that they complete and submit the form directly to the Chiropractic Quality Assurance Commission.

By submitting this application, you give consent to such an examination(s). You also agree the examination report(s) may be provided to the licensing authority. You waive all claims based on confidentiality or privileged communication. If you do not submit to a required examination(s) or provide the report(s) to the licensing authority, your application may be denied.

2. Do you currently use chemical substance(s) in any way which impair or limit your ability to practice your profession with reasonable skill and safety? If yes, please explain.....

“Chemical substances” include alcohol, drugs, or medications, whether taken legally or illegally.

“Currently” means within the past two years.

Illegal use of controlled substances is the use of controlled substances (e.g., heroin, cocaine) not obtained legally or taken according to the directions of a licensed health care practitioner.

Note: If you answer “yes” to any of the remaining questions, provide an explanation and certified copies of all judgments, decisions, orders, agreements and surrenders. The department does criminal background checks on all applicants.

5. Have you **ever** been convicted, entered a plea of guilty, no contest, or a similar plea, or had prosecution or a sentence deferred or suspended as an adult or juvenile in any state or jurisdiction? ..

Note: If you answered “yes” to question 5, you must send certified copies of all court documents related to your criminal history with your application. If you do not provide the documents, your application is incomplete and will not be considered.

To protect the public, the department considers criminal history. A criminal history may not automatically bar you from obtaining a credential. However, failure to report criminal history may result in extra cost to you and the application may be delayed or denied.
