Akka heera mirgoota siviilii Federaalaa fi Qajeelchawwanii fi Dambiiwwan U.S. Department of Agriculture (USDA, mirgoota siviilii Dippaartimentii Qonnaa U.S) tti, USDA'n, Ejensiiwwan, waajjirawwan, fi hojjetootni isaa, fi dhaabbileen sagantaawwan USDA keessatti hirmaataa jiran yookaan bulchaa jiran sanyii, halluu, biyya dhalootaa, saala, qaama-hir'ummaa, umurii, yookiin ijaa-ba'umsa humna-waraanaa fi dhaabbata siyaasaa yookiin gocha-miidhaa sababii gocha mirgoota siviilii irratti hundaa'uun sagantaa kamiyyu keessatti yookiin raawwii USDA 'n taasifame yookiin baajateeffame keessatti looguurrara kan dhorkamanidha.

Namootni qaama-hir'ummaa qaban odeeffannoo sagantaatiif maloota waliin dudubbannaa filannoowwan kanneen biroo (fakkeenyaaf, Sirna-barreessuu qaro-dhabeeyyii, maxxansa guguddaa, waraabduu sagalee, Afaan Mallattoo Ameerikaa, fi kan kana fakkaatan) kanneen isaan barbaachisan, Ejensicha qunnamuu qabu (kan Mootummaa-naannoo yookiin gandaa) kunis iddoo itti faayidaawwanii ifyyatanitti. Namootni duudaa, sirriitti kanneen hin dhageenye yookiin qaama-hir'ummaawwan dudubbii kanneen qaban karaa Federal Relay Service (Tajaajila Dabarsaa Federaalaatiin) lakkoofsa (800) 877-8339 irraan USDA qunnamuu ni danda'u. Dabalataanis, odeeffannoon sagantaa afaan Ingiliziin alas afaanota birootiin tarii akka argaman ni taasifama.
